Subject: Bylaws to Regulate Short-term Rental Accommodation - Final Readings

# **PURPOSE:**

For Council to consider adoption of three bylaws in order to permit the operation of short-term rentals in Courtenay and regulate their use:

- 1. Zoning Amendment Bylaw No. 3134, 2025 (short-term rental accommodation) to amend Zoning Bylaw No. 2500, 2007;
- 2. Business Licence Amendment Bylaw No. 3133, 2025 (short-term rental accommodation) to amend Business Licence Bylaw No. 2523, 2008; and
- 3. Municipal Ticket Information Amendment Bylaw No. 3139, 2025 (short-term rental accommodation) to amend Municipal Ticket Information Bylaw No. 2435, 2006.

#### **BACKGROUND:**

Council held a public hearing for *Zoning – Amendment Bylaw No. 3134, 2025 (short-term rental accommodation)* on April 30, 2025.

Council gave Third Reading to the following bylaws at the Special Council meeting on April 30, 2025:

- Zoning Amendment Bylaw No. 3134, 2025 (short-term rental accommodation),
- Business Licence Amendment Bylaw No. 3133, 2025 (short-term rental accommodation), and
- Municipal Ticket Information Amendment Bylaw No. 3139, 2025 (short-term rental accommodation).

Section 52 (3) (a) of the Transportation Act requires that the Ministry of Transportation and Transit approves zoning bylaws that are within 800 metres of a controlled access intersection.

The Business Licence Bylaw and Municipal Ticket Information Bylaw amendments do not require Ministry of Transportation approval.

# **DISCUSSION:**

Ministry of Transportation and Transit has approved *Zoning – Amendment Bylaw No. 3134, 2025 (short-term rental accommodation)*, and staff recommend adoption of the bylaws.
