# **Bylaw No. 3185**

A bylaw to establish regulations and process for the Bylaw Dispute Adjudication System

WHEREAS, in accordance with section 260 of the Community Charter, local governments are granted the authority to establish bylaws for the purpose of enforcing their bylaws;

NOW, THEREFORE, the Council of the City of Courtenay, assembled in an open meeting, enacts as follows:

# Citation

1. This bylaw shall be cited as the "Municipal Enforcement Bylaw No. 3185".

# Definitions

- 2. In this bylaw, "City" means the City of Courtenay.
- 3. In Part 2 of this bylaw, "LGBNE Act" means the *Local Government Bylaw Notice Enforcement Act*, SBC 2003, c. 60 and regulations enacted thereunder.
- 4. The terms in Part 2 of this bylaw have the same meaning as the terms defined in the LGBNE Act.
- 5. In Part 3 of this bylaw, "*Charter*" means the *Community Charter*, SBC 2003, c. 26 and regulations enacted thereunder.

"municipal ticket" means a ticket for a bylaw offence issued under section 264 of the *Charter*.

# Application

- 6. This Bylaw applies to the Municipal Enforcement Bylaw No. 3185 for the City of Courtenay.
- 7. The attached schedule A & B form part of this Bylaw.

#### Severability

8. If any portion of this bylaw is held by a court of competent jurisdiction, then the invalid portion shall be severed from the bylaw and the remainder of the bylaw shall be deemed to have been adopted without the severed portion.

# Part 2 – Bylaw Notices

# Designation of Bylaw Contraventions for Bylaw Notices

- 9. The bylaw contraventions designated in Appendix "A" of this bylaw may be dealt with by bylaw notice pursuant to the LGBNE Act.
- 10. The descriptions set forth in Column 1 of Appendix "A" of this bylaw are authorized to be used on a bylaw notice to designate a contravention under the bylaw section number appearing in Column 2 of Appendix "A" opposite the respective description.

# Penalties for Bylaw Notices

- 11. The penalty for a bylaw contravention designated in Appendix "A" of this bylaw is as follows:
  - a. subject to subsection (b) to (d), the penalty set out in Column 3 of Appendix "A" of this bylaw corresponding to the contravention;
  - b. if received by the City within 14 days of the person receiving or being presumed to have received the bylaw notice, the discounted penalty for early payment set out in Column 4 of Appendix "A" of this bylaw corresponding to the contravention;
  - c. if more than 30 days after the person received or is presumed to have received the bylaw notice, the penalty for late payment set out in Column 5 of Appendix "A" of this bylaw corresponding to the contravention; or
  - d. if a person who disputes a bylaw notice enters into and complies with a compliance agreement, where available as specified in Column 6 of Appendix "A", the penalty set out in Column 3 of Appendix "A" of this bylaw corresponding to the contravention, discounted by 50%.

# Period for Paying or Disputing Bylaw Notice

- 12. A person who receives a bylaw notice must, within 14 days of the date on which the person received or is presumed to have received the bylaw notice:
  - a. pay the penalty set out in section 11, or

- b. request dispute adjudication by filling in the appropriate portion of the bylaw notice indicating either a payment or a dispute and delivering it either in person during regular office hours, by mail, or on-line at <u>bylaw@courtenay.ca</u> to the City municipal hall.
- 13. A person may pay the penalty after 14 days of receiving the bylaw notice in accordance with section 11, but no person may dispute the notice after 14 days of receiving or being presumed to have received the bylaw notice.
- 14. If a person was not served personally with a bylaw notice and advises the City that they did not receive a copy of the bylaw notice within 21 days of receiving or being presumed to have received a notice from the City that the amount under the bylaw notice is owing, the time limits for responding to a bylaw notice under this bylaw do not begin to run until a copy of the bylaw notice is re-issued and delivered in accordance with the LGBNE Act.

# City Bylaw Notice Dispute Adjudication System

- 15. In accordance with the LGBNE Act, the City Bylaw Notice Dispute Adjudication System is established as a dispute adjudication system to resolve disputes in relation to bylaw notices.
- 16. The civic address of the office of the City Bylaw Notice Dispute Adjudication System is 830 Cliffe Ave, Courtenay, V9N 2J7, British Columbia.
- 17. Every person that elects dispute adjudication and is unsuccessful in the dispute adjudication in relation to a bylaw notice must pay the City a fee of \$25.00 in addition to the penalty set out in section 11 for the purposes of the City recovering the costs of the City Bylaw Notice Dispute Adjudication System.

# **Screening Officers**

- 18. The position of screening officer is established.
- 19. The following are designated classes of persons that may be appointed by the City as screening officers:
  - a. Director of Corporate Services;
  - b. Director of Public Works;
  - c. Manager of Bylaw Enforcement;
  - d. Manager of Parks;
  - e. Manager of Solid Waste Services;

- f. Manager of Buildings and Administrative Services;
- g. Bylaw Enforcement Officer; and
- h. Bylaw Screening Clerk;

and Council may appoint screening officers from these classes of persons by name of office or otherwise.

# Powers, Duties and Functions of Screening Officers

- 20. The powers, duties and functions of a screening officer are as set out in the LGBNE Act, and include the following:
  - a. when requested by the person against whom a bylaw contravention is alleged, communicate information with respect to the contravention including the nature of the contravention, the provision of the bylaw contravened, the penalty for the contravention and fees in relation to the City Bylaw Notice Dispute Adjudication System;
  - b. communicate with any or all of the following for the purposes of performing their functions under this bylaw or the LGBNE Act:
    - i. the person against whom a bylaw contravention is alleged or their representative;
    - ii. the person who issued the bylaw notice;
    - iii. the complainant or their representative;
    - iv. the City's staff regarding the disputant's history of bylaw compliance;
  - c. review the City's records regarding the disputant's history of bylaw compliance;
  - d. cancel bylaw notices in accordance with the LGBNE Act or the City's policies;
  - e. prepare and enter into compliance agreements under the LGBNE Act with a person who disputes a bylaw notice for specified bylaw contraventions and as part of the process may establish terms and conditions the screening officer considers necessary or advisable, including time periods for payment of penalties and compliance with the bylaw;
  - f. provide for payment of a reduced amount of the penalty if a compliance agreement is entered into, as provided in section 11.
- 21. The bylaw contraventions in relation to which a screening officer may enter into a compliance agreement are those set out in Column 6 of Appendix "A".

- 22. The maximum duration of a compliance agreement is one year.
- 23. A screening officer may not screen a bylaw notice which they have issued.

# Form of Bylaw Notice

24. The City may, from time to time, provide for the form of the bylaw notice, provided that the bylaw notice complies with section 4 of the LGBNE Act.

# Part 2 – Municipal Ticketing for Bylaw Offences

# **Designation of Bylaw for Municipal Ticket**

- 25. The bylaw offences designated in Appendix "B" of this bylaw may be enforced by means of a municipal ticket under section 264 of the *Charter*.
- 26. The expressions set forth in Column 1 of Appendix "B" of this bylaw are authorized to be used on a municipal ticket to designate the offence committed under the bylaw section number appearing in Column 2 of Appendix "B" opposite the respective expression.

# **Fines for Municipal Tickets**

- 27. The fine for an offence against a bylaw designated in Appendix "B" of this bylaw is as follows:
  - a. Subject to subsection (b), the fine set out in Column 3 of Appendix "B" of this bylaw corresponding to the offence;
  - b. If received by the City on or before the 30<sup>th</sup> day from the date on which the municipal ticket is served, the discounted penalty set out in Column 4 of Appendix "B" of this bylaw corresponding to the offence.

#### Period for Paying or Disputing Municipal Ticket

- 28. A person who receives a municipal ticket must, within 14 days after the date of service:
  - a. pay the fine indicated on the municipal ticket to the City, in accordance with the instructions indicated on the municipal ticket, or
  - b. dispute the allegation contained in the municipal ticket in accordance with section 267 of the *Charter*.

# **Hearing of Dispute**

29. If notice of dispute of municipal ticket is given in accordance with section 267 of the *Charter*, the ticket will be referred to the Provincial Court for a hearing.

# Previous Bylaw Repealed

30. The "City of Courtenay Municipal Ticket Information Bylaw No. 2435, 2006" as amended, is hereby repealed.
