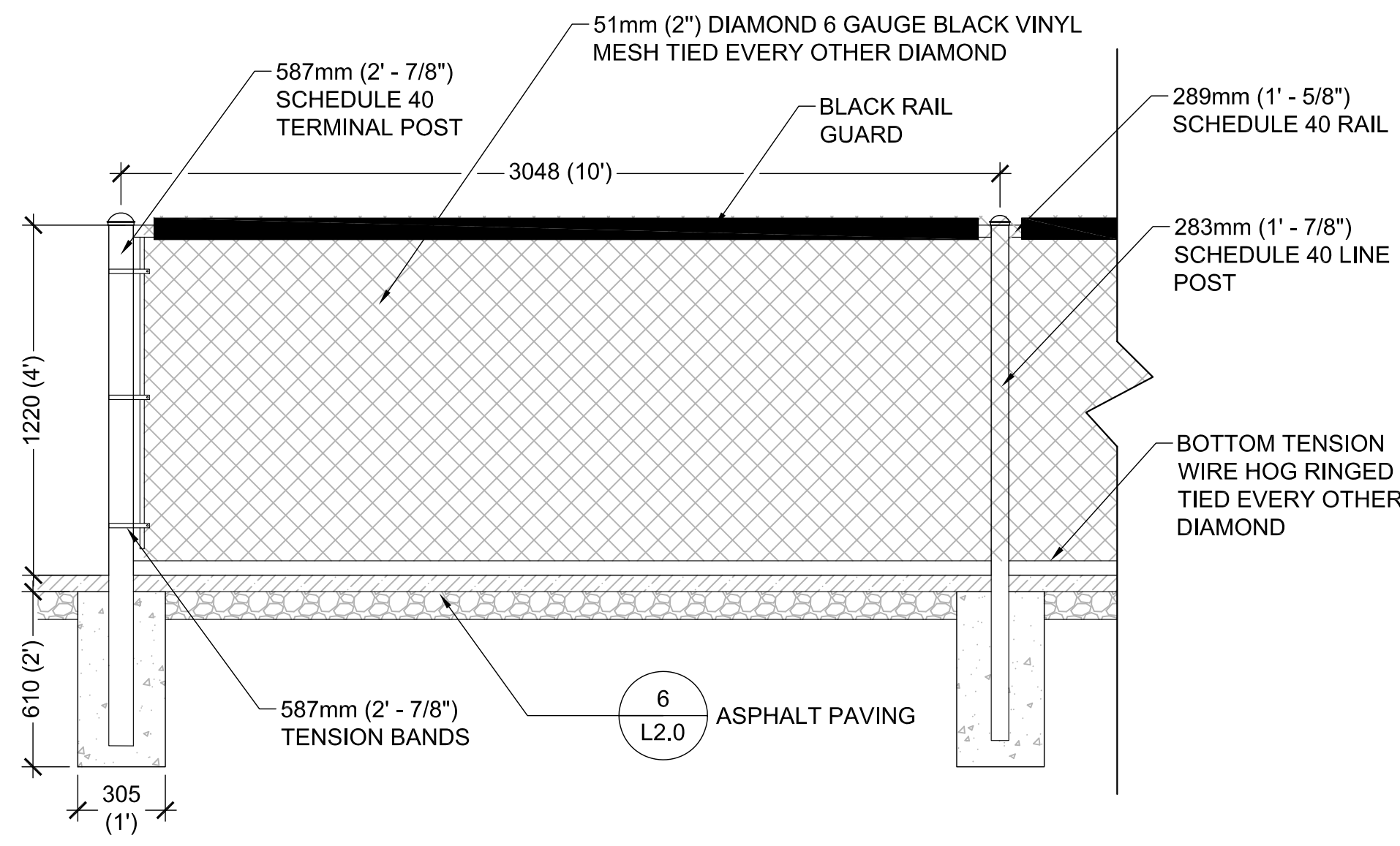

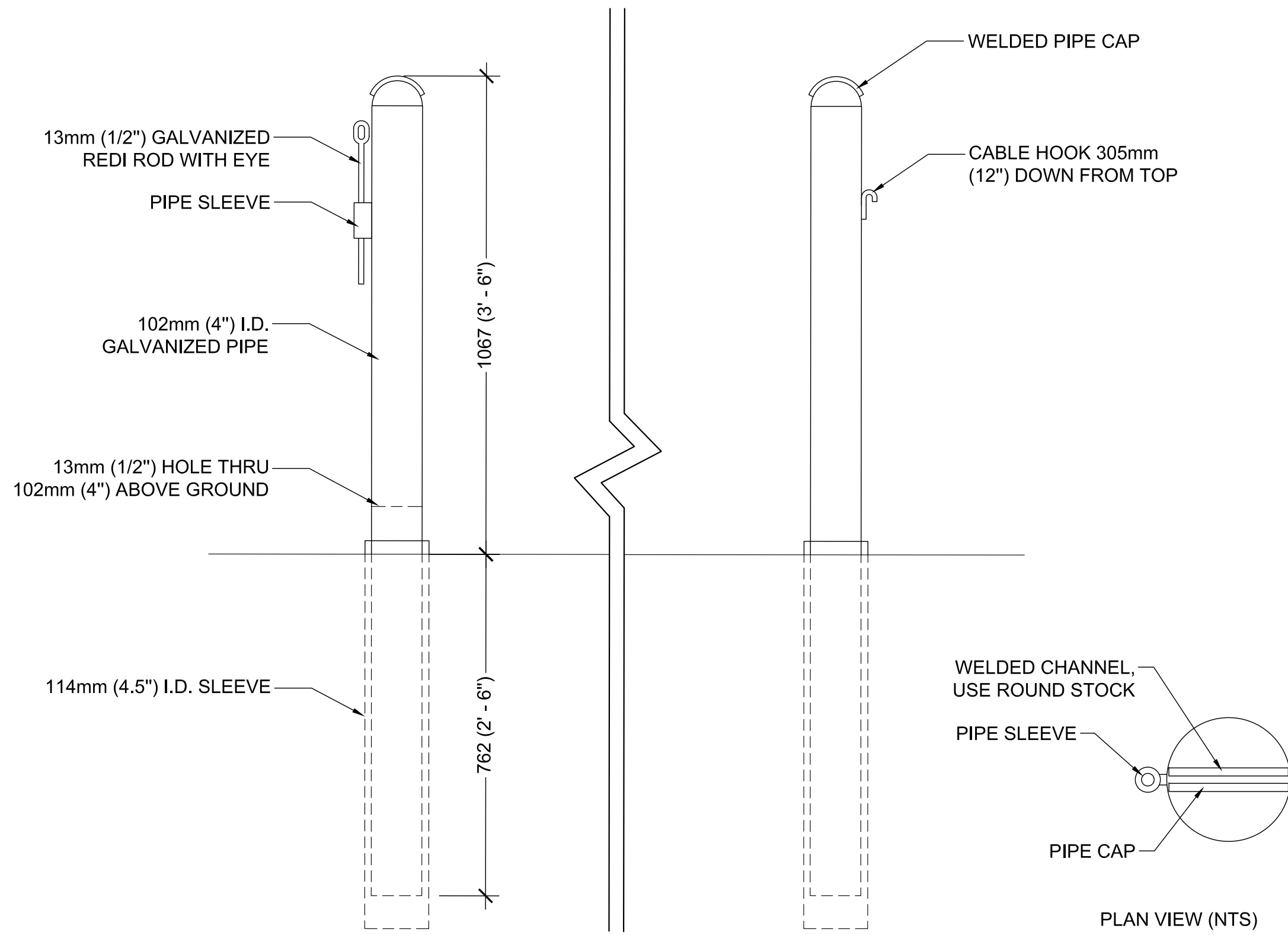


**1 TYPICAL 4' FENCE ELEVATION**

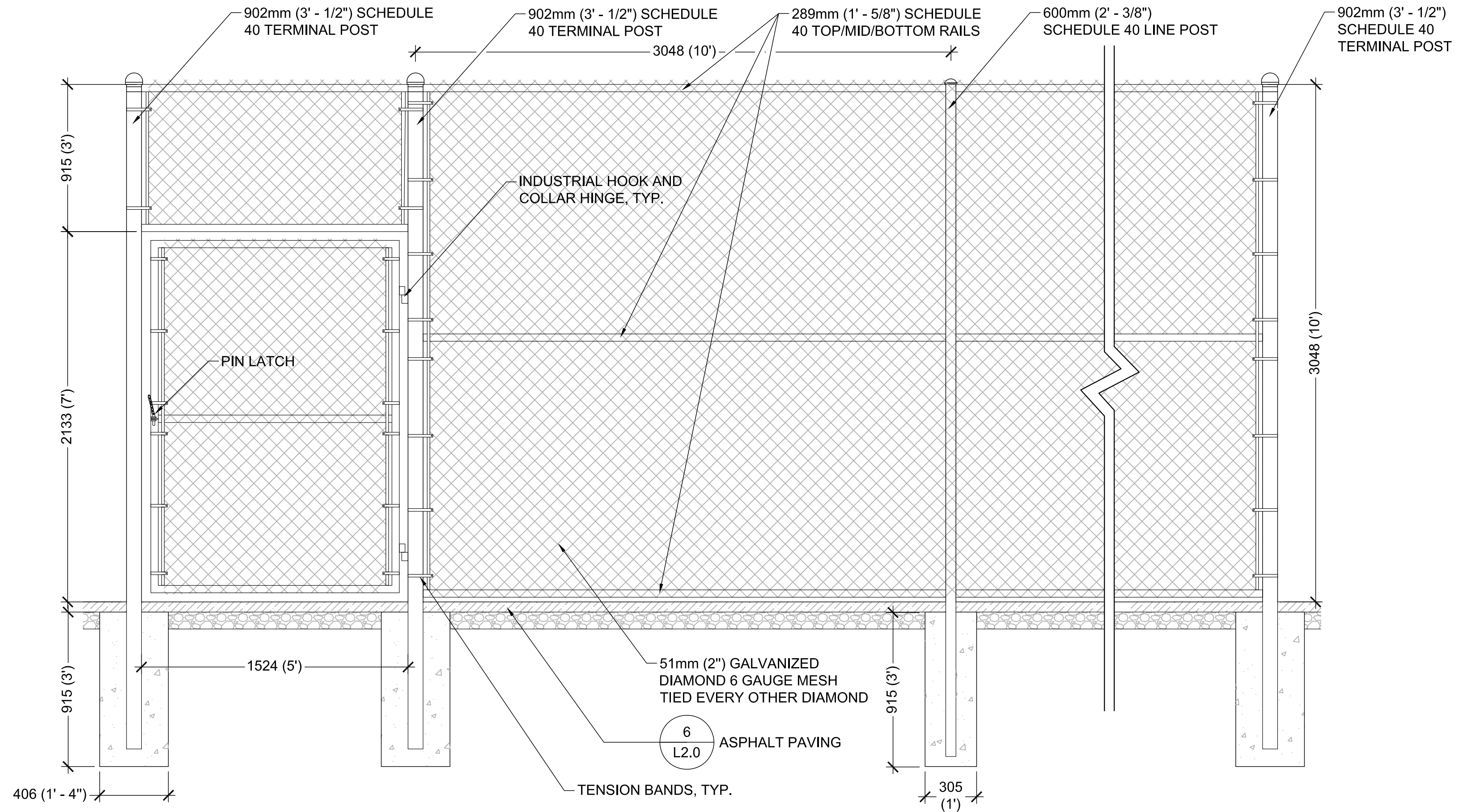

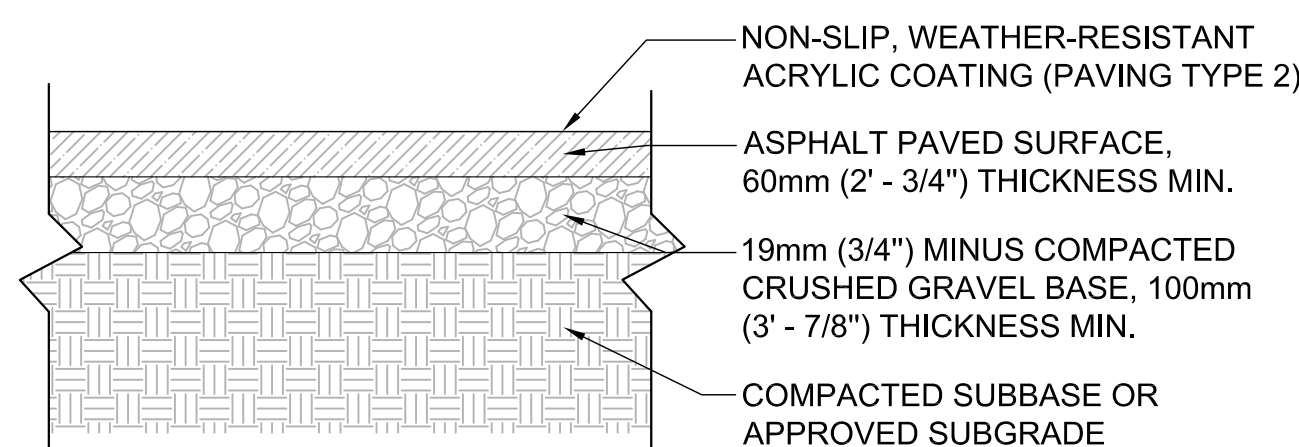

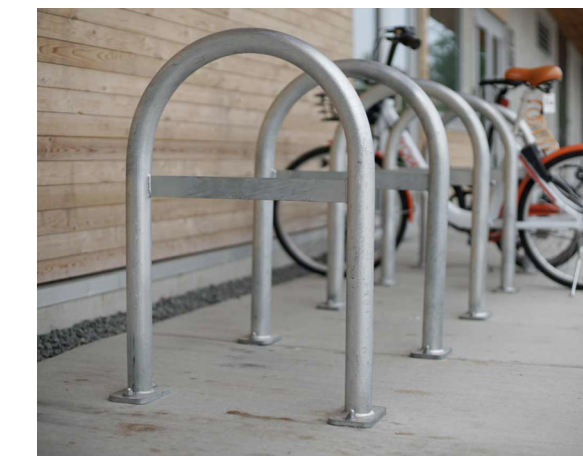
